Official Notice of Annual Meeting & Election of Officers

Georgia Power Valdosta FCU will hold its **57th Annual Meeting on Tuesday, March 24, 2015** at 5:30 PM in the **J.E. Mathis Municipal Auditorium, 2300 North Ashley St., Valdosta, Ga.** Every credit union member is personally invited to this important yearly meeting. All who attend will be treated to refreshments and eligible for door prizes. Credit union members will hear a brief report on the credit union's past financial year and also have the opportunity to vote for open positions on the credit union Board of Directors.

In accordance with the credit union's bylaws, Board Chair, Charles Ray, appointed a nominating committee to select candidates to fill the 3 year terms for the board positions up for election. The following members have been nominated and have accepted nomination by the nominating committee:

Rebecca (Beckie) Ann Mayer-Worked with Dr. Gary Hutchinson, D.C. for 14 yrs. as office manager; worked for Lowndes Co. Transportation for 13 yrs. as a school bus driver/trainer; was active with Lowndes High Ga. Bridgemen for 4 yrs.; past member and officer of the Women of Ga. Power Co., member Georgia Power Valdosta FCU since 1977, Georgia Power Valdosta FCU Board Member since 2009; active member of Lake Park 1st Baptist Church.
Audie Jones-Employed with Saft America, Inc. 34 years as a Controller; graduated from VSU with a Masters of Business and a Masters of Accounting; Deacon at Union Cathedral; member of Georgia Power Valdosta FCU since 1996.

Tiffany Thomas-Works at Ga. Power Co. as a Distribution Support Rep. for 7 yrs.; graduated from VSU with a Bachelors Degree and graduated from Capella University with a Masters Degree in HR Mgmt.; has been a member of Georgia Power Valdosta FCU since 2010.

In addition to the nominating committee's candidates to fill the 3-yr. terms for the board positions up or election, the Board Chair is calling for nominations by petition from the membership. **The 2014 board election will require candidates to petition, if not selected by nominating committee, and there will be no nominations from the floor when there is at least one nominee for each position to be filled.**

Candidates for Board of Director, whether nominated by committee or petition, must meet specific qualifying guidelines in order to have their names placed on the ballot. Candidates nominated by petition must submit a brief statement of qualifications and biographical data along with a petition bearing signatures of at least 1% of the credit union's membership. The number of signatures needed for the 2015 elections is 36.

All forms needed for nominations by the petition (Petition, Board Statement of Qualifications Application for Board of Director, and Certification of Service) can be picked up at the credit union's main office located at **1707 Dow St., Valdosta, Ga. 31601**; or can be mailed to address requested. The Petition, Application and Certificate must be submitted to the Secretary of the Credit Union at least 40 days prior to the annual meeting.
